PRIVACY POLICY

Flying Car is committed to protecting your privacy. This Privacy Policy describes the practices regarding the Personal Data (as defined below) that is collected from users of the Flying Car website, such as the website located at www.flyingcarcomputers.com (the "Site") and the forms, agreements and other materials that are made available or enabled via the Site (the "Flying Car Materials") (collectively, the "Flying Car Website").

1. Questions; Contact; Reporting Violations. If you have any questions or concerns or complaints about our Privacy Policy or our data collection or processing practices, or if you want to report any security violations to us, please contact us at the following address:

- 2. About Children. We do not intentionally gather Personal Data from visitors in the US who are under the age of 13. If a child under 13 submits Personal Data to Flying Car and we learn that the Personal Data is the information of a child under 13, we will attempt to delete the information as soon as possible. If you believe that we might have any Personal Data from a child under 13, please contact us at privacy@flyingcarcomputers.com.
- **3.** Users Outside of the United States. If you are a user of the Flying Car Website who resides in a country other than the United States this section applies to you:

3.1. If you reside in the UK or any country within the European Economic Area ("EEA"):

3.1.1. Flying Car is the Controller (for the purposes of the General Data Protection Regulation 2016/679 ("GDPR") and any implementing legislation or legislation having equivalent effect in the UK (together, "EU Data Protection Legislation")) of your Personal Data.

- 3.1.2. The legal basis of our processing of your Personal Data as described in this Privacy Policy is our legitimate interests where those interests are not overridden by the impact on you (unless our processing is otherwise required or permitted by law). If you have questions about the legal basis of how we process your personal information, please contact us at the address above.
- 3.1.3. We ask that you not provide us with any Special Category Personal Data (as defined in the GDPR), e.g., information related to racial or ethnic origin, political opinions, religion or other beliefs, health, biometrics or genetic characteristics, or trade union membership, or any criminal background information. If you do not consent to our processing and use of such sensitive information, you must not submit such sensitive information through the Flying Car Website.
- 3.2. If you reside in Singapore:
 - 3.2.1. You agree that your accessing or using the Flying Car Website in any way constitutes your agreement that (a) we may process your Personal Data for the purposes identified in the Privacy Policy, and (b) your Personal Data may be transferred to and processed in the country in which it was collected and in other countries, including the United States, where laws regarding processing of Personal Data may be less stringent than the laws in your country.
- 4. Types of Data We Collect. "Personal Data" means data that allows someone to identify or contact you, including, for example, your name, address, telephone number, e-mail address, as well as any other nonpublic information about you that is associated with or linked to any of the foregoing data. "Anonymous Data" means data that is not associated with or linked to your Personal Data; Anonymous Data does not, by itself, permit the identification of individual persons. We collect Personal Data and Anonymous Data, as described below.
 - 4.1. Information You Provide to Us.
 - 4.1.1. We may collect Personal Data from you, such as your first and last name, e-mail, mailing address, and phone number.

- 4.1.2. If you provide us feedback or contact us via e-mail, we will collect your name and e-mail address, as well as any other content included in the form, in order to send you a reply.
- 4.1.3. We may also collect Personal Data at other points in the Flying Car Website that states that Personal Data is being collected.
- 4.2. Information Collected via Technology.
 - 4.2.1. Information Collected by Our Servers. To make our Flying Car Website more useful to you, our servers (which may be hosted by a third party service provider) collect information from you, including your browser type, operating system, Internet Protocol ("IP") address (a number that is automatically assigned to your computer when you use the Internet, which may vary from session to session), domain name, and/or a date/time stamp for your visit.
 - 4.2.2. Log Files. As is true of most websites, we gather certain information automatically and store it in log files. This information includes IP addresses, browser type, Internet service provider ("ISP"), referring/exit pages, operating system, date/ time stamp, and clickstream data. We use this information to analyze trends, administer the Flying Car Website, track users' movements around the Flying Car Website, and to gather demographic information about our user base as a whole.
 - 4.2.3. <u>Cookies</u>. Like many online services, we use cookies to collect information. "Cookies" are text files containing small amounts of information which are downloaded to your computer or mobile device when you visit a website or mobile application. Cookies are then sent back to the originating site on each subsequent visit, or to another site that recognizes those cookies. You can find out more information about cookies at http:// www.allaboutcookies.org/. Cookies are widely used in order to make sites work, or to work more efficiently, as well as to provide information to the owners of the platform. We use cookies to enhance the online experience of our visitors and to better understand how our site is used. Cookies may tell us, for example, whether you have visited our site before or whether you

are a new visitor. This type of information is collected to make the Flying Car Website more useful to you. "Cookies" are small pieces of information that a website sends to your computer's hard drive while you are viewing the website. We may use both session Cookies (which expire once you close your web browser) and persistent Cookies (which stay on your computer until you delete them) to provide you with a more personal and interactive experience on the Flying Car Website. The Flying Car Website uses the following types of cookies:

- 4.2.3.1. <u>Cookies necessary for essential purposes</u>. These cookies are essential to provide you with services available through our site and to use some of its features.
- 4.2.3.2. <u>Analytics Cookies</u>. These cookies are used to collect information about how visitors use our site. The information gathered does not identify any individual visitor and is aggregated. We use this information to help operate our site more efficiently, to gather broad demographic information and to monitor the level of activity on our site.
- 4.2.3.3. <u>Performance Cookies</u>. These cookies collect information about how visitors use the site, so that we can analyse traffic and understand how our site is performing.
- 4.2.3.4. <u>Functionality Cookies</u>. These cookies allow our site to remember choices you make and provide enhanced, more personal features. The information these cookies collect may be anonymized and they cannot track your browsing activity on other websites.
- 4.3. <u>Pixel Tags</u>. We may use "Pixel Tags" (also referred to as clear Gifs, Web beacons, or Web bugs). We may use this information to reduce or eliminate messages sent to a user. We do not tie the information gathered by Pixel Tags to our users' Personal Data.
- 4.4. <u>Collection of Data by Advertisers</u>. We do not use third parties to serve ads on the Site or collect personally identifiable information about your online activities over time and across different websites.

5. Use of Your Personal Data

- 5.1. **General Use**. In general, Personal Data you submit to us is used to respond to requests that you make. We use your Personal Data in the following ways:
 - 5.1.1. to provide improved administration of the Flying Car Website;
 - 5.1.2. to improve the quality of experience when you interact with the Flying Car Website;
 - 5.1.3. to send you follow-up communications when you contact us via e-mail or submit feedback; and
 - 5.1.4. to send you administrative e-mail notifications, such as updates regarding the Flying Car Website, security, or support and maintenance advisories.
- 5.2. Creation of Anonymous Data. We may create Anonymous Data records from Personal Data by excluding information (such as your name) that makes the data personally identifiable to you. We use this Anonymous Data to analyze request and usage patterns so that we may enhance the content of, and improve navigation on, the Flying Car Website.
- 6. **Disclosure of Your Personal Data.** We disclose your Personal Data as described below and as described elsewhere in this Privacy Policy.
 - 6.1. <u>Third Party Service Providers</u>. We may share your Personal Data with third party service providers to provide you with the Flying Car Materials and/or to provide other services to Flying Car. These third party service providers are required not to use your Personal Data other than to provide the services requested by Flying Car.
 - 6.2. <u>Other Disclosures</u>. Regardless of any choices you make regarding your Personal Data (as described in Section 8 below), Flying Car may disclose Personal Data if it believes in good faith that such disclosure is necessary (a) in connection with any legal investigation; (b) to comply with relevant laws or to respond to subpoenas or warrants served on Flying Car; and/or (c) to investigate or assist in preventing any violation or potential violation of the law, this Privacy Policy.

- 7. Third Party Websites. The Flying Car Website may contain links to third party websites. When you click on a link to any other website or location, you will leave our Site and go to another site, and another entity may collect Personal Data or Anonymous Data from you. We have no control over, do not review, and cannot be responsible for, these outside websites or their content. Please be aware that the terms of this Privacy Policy do not apply to these outside websites or content, or to any collection of your Personal Data after you click on links to such outside websites. We encourage you to read the privacy policies of every website you visit. The links to third party websites or locations are for your convenience and do not signify our endorsement of such third parties or their products, content or websites.
- 8. **Your Choices Regarding Information**. You have several choices regarding the use of information on the Flying Car Website:
 - 8.1. <u>Email Communications</u>. We may periodically send you free newsletters and promotional e-mails if you have indicated that you would like us to do so. When you receive newsletters or promotional communications from us, you may indicate a preference to stop receiving further communications from us and you will have the opportunity to "optout" by following the unsubscribe instructions provided in the e-mail you receive or by contacting us directly (please see contact information above). Despite your indicated e-mail preferences, we may send you service related communications, including notices of any updates to our Privacy Policy.
 - 8.2. <u>Cookies</u>. If you decide at any time that you no longer wish to accept Cookies from the Flying Car Website for any of the purposes described above, then you can instruct your browser, by changing its settings, to stop accepting Cookies or to prompt you before accepting a Cookie from the websites you visit. Consult your browser's technical information. If you do not accept Cookies, however, you may not be able to use all portions, or all functionality, of the Flying Car Website. If you have any questions about how to disable or modify Cookies, please let us know at the contact information provided above.
 - 8.3. <u>Changing or Deleting Your Personal Data</u>. You may request deletion of your Personal Data by us, and we will use commercially reasonable efforts to honor your request, but please note that we may be required

by law to keep such information and not delete it. If you reside in Singapore, we will take commercially reasonable efforts to ensure that your Personal Data in our possession or under our control is destroyed and/or anonymized as soon as it is reasonable to assume that (i) the purpose for which your Personal Data was collected is no longer being served by the retention of such Personal Data.

8.4. Your Rights Regarding Your Personal Data.

- 8.4.1. If you reside in the UK or EEA, you have certain, you have certain rights regarding your Personal Data and may, in certain circumstances, ask us to take the following actions in relation to such data:
 - 8.4.1.1. provide you with information about our processing of your Personal Data and give you access to such data.
 - 8.4.1.2. update or correct inaccuracies in your Personal Data.
 - 8.4.1.3. delete your Personal Data.
 - 8.4.1.4. transfer a machine-readable copy of your Personal Data to you or a third party of your choice.
 - 8.4.1.5. restrict the processing of your Personal Data.
 - 8.4.1.6. object to our reliance on our legitimate interests as the basis of our processing of your Personal Data that impacts your rights.
- 8.4.2. If you reside in Singapore, you may request to access and/or correct your Personal Data currently in our possession by writing to us. Please note that we may charge you a reasonable fee for the handling and processing of your requests to access your Personal Data.
- 9. Changes to This Privacy Policy. This Privacy Policy may be updated from time to time for any reason. We will notify you of any changes to our Privacy Policy by posting the new Privacy Policy and we will change the "Last Updated" date above. You should consult this Privacy Policy regularly for any changes.
